Let the Court Fees be cancelled and let necessary entry be made in the register.</p> <p>The Application is also accompanied by an affidavit duly sworn by the Applicant and is in order.</p> <p>Admit and register it as Caveat application No. <u>1</u> of 2019.</p> <p>Also seen Vakalatnama duly executed by the Applicant in favour of Shri. H. Laltanpuia, Advocate and the same is accepted.</p> <p>Heard the Ld. Counsel for the Applicant who submits that the caveator, Power Grid Corporation of India Ltd is a Government of India enterprise and a licensee engaged in the business of inter-state transmission of electricity operating under Ministry of Power. Power Grid Corporation of India Ltd has also been notified as Central transmission utility under section 38 of the Electricity Act, 2003. That the Government of India, Ministry of Power vide Notification Dated 24.12.1004, in exercise of Power conferred by Section 164 of the Electricity Act, 2003 has authorized the Caveator to exercise all the powers vested in the Telegraph Authority under Part III of the Indian Telegraph Act, 1885, in respect of all the electrical lines and electrical plant established or maintained or to be established or maintained for transmission of electricity or for the purpose of Telephonic or telegraphic communication necessary for the proper co-ordination of the work. That the caveator, is operating and maintaining 132 KV extra High Voltage Transmission line from Aizawl to Kumarghat (Tripura) for importing of Electrical Power from Mizoram since Feb, 1989. That for the construction of Railway Line from Bairabi to Sihmui, a section of the above transmission line (6 nos of towers) is required to be diverted to new route.
